We encourage each Authorized Agent to share this memorandum with your unit of government's chief financial officer, other officials, and governing body members.

Beginning April 20, 2015, IMRF will present a series of Employer Rate Meetings throughout the state. These meetings will review the impact of year-end financial and actuarial data on IMRF, and the data's estimated impact on individual employers.

Generally, each Employer Rate Meeting lasts approximately one-and-a-half hours and consist of a formal presentation followed by a question-and-answer session. We encourage you, your chief financial officer, other officials, governing body members, and interested parties from your employer to attend the meeting scheduled in your area (*see the full schedule on page 2*).

Advance registration is requested for the Employer Rate Meetings. You can register online through IMRF Employer Access.
