# IMRF Performance Summary

- The Illinois Municipal Retirement Fund (“IMRF”) ended October 2021 with a market value of \$56.6 billion, up for the month by approximately \$1.7 billion. IMRF returned +3.33% during the month, outperforming the Total Fund Benchmark which returned +3.06%. Total Fund outperformance was primarily driven by an overweight to U.S. Equity and an underweight to Fixed Income, as the U.S. Equity market rebounded during October, returning +6.76% during the month.
  - Year-to-date, IMRF has returned +15.48% versus its benchmark of +11.50%.
- The U.S. Equity Portfolio underperformed the Russell 3000 Index during the month, returning +5.99% versus +6.76%. In aggregate, investment manager relative performance in Large Cap and Small Cap was challenged during the market rally and underperformed their respective benchmarks.
  - Year-to-date; however, the U.S. Equity Portfolio has outperformed the benchmark, returning +23.22% versus +22.77%.
- The Internally Managed Scientific Beta Portfolio underperformed the benchmark during October, returning +5.44% versus +5.68%. Since inception, the strategy has outperformed the benchmark, returning +16.39% versus +15.69%.
- The Internally Managed GSAM-Factor Diversity Portfolio underperformed the benchmark during the month, returning +6.56% versus +6.87%.
- The Public Real Assets Portfolio outperformed its benchmark during the month, returning +4.19% versus +3.84%.
- The International Equity Portfolio underperformed the benchmark during October, returning +1.70% versus +2.39%. In aggregate, investment managers in Large Cap Value and Large Cap Core underperformed the benchmark during the month.
  - Year-to-date, IMRF’s International Equity Portfolio continues to deliver strong relative performance, returning +10.73% versus +8.43% for the benchmark.
- The Fixed Income Portfolio modestly underperformed the benchmark during October, returning -0.10% versus -0.03%. The Portfolio’s dedicated allocation to Emerging Markets and High Yield were among the largest detractors from relative outperformance as those markets underperformed the Bloomberg U.S. Aggregate Index during the month, returning -1.40% and -0.30%, respectively. Year-to-date; however, these dedicated allocations continue to benefit overall relative performance of the Portfolio.
  - IMRF’s Fixed Income Portfolio has returned -0.61% versus -1.58% for the benchmark, year-to-date.
- As of October month-end, all underlying asset class allocations in the Portfolio are within the stated four percent point rebalancing range as outlined by the current Statement of Investment Policy. IMRF has made considerable progress implementing the rebalancing recommendation presented at the August 2021 Board of Trustees Meeting.
