Monthly Performance Summary

As of September 30, 2022

IMRF Performance Summary

- The Illinois Municipal Retirement Fund (“IMRF”) ended September 2022 with a market value of \$45.5 billion, down for the month by approximately \$3.30 billion. IMRF returned -6.04% during the month, outperforming the Total Fund Benchmark, which returned -6.95%. Financial markets and global economies continued to be challenged in September as monetary policy tightening continued in both the US and Europe.
- The U.S. Equity markets were down for the month amid one of the worst sell offs in the past 20 years. The U.S. Equity Portfolio outperformed the benchmark during the month, returning -9.42% versus -9.45%. In aggregate, investment manager performance in Public Real Assets was the largest contributor to relative outperformance.
- International Equity market performance was negative for the month. China faced slowing growth and European markets suffered amid an energy crisis and a large sell-off of UK government bonds. The International Equity Portfolio outperformed the benchmark during September, returning -9.96% versus -9.99%. Investment manager performance in Large Cap Core was the largest contributor to relative outperformance.
- U.S. Treasury yields ended the month up across all maturities. The 10-year Treasury closed the month up 81 bps from June. The Fixed Income Portfolio underperformed the benchmark during the month, returning -4.13% versus -4.02%. Investment manager performance in Bank Loans the largest contributor to relative underperformance.
- As of September month-end, all underlying asset class allocations in the Portfolio are within the stated four percentage point rebalancing range as outlined by the current Statement of Investment Policy.
