IMRF Performance Summary

- The Illinois Municipal Retirement Fund (“IMRF”) ended August 2023 with a market value of \$50.7 billion, down for the month by approximately \$1.1 billion. IMRF returned -1.73% during the month, in line with the Total Fund Benchmark, which returned -1.72%. Growth and defensive assets generally declined during the month as U.S. economic data remained strong, increasing concerns regarding future rate hikes.
- The broad U.S. Equity market was negative for the month, with Large Cap stocks outperforming Small Cap. The U.S. Equity Portfolio underperformed its benchmark during August, returning -2.65% versus -2.18%. Investment manager performance in Large Cap Growth was the largest contributor to relative underperformance.
- International Equity markets were negative in August, while Emerging Markets underperformed Developed in part due to continued softness in the Chinese Economy. The International Equity portfolio outperformed the benchmark during the month, returning -3.66% versus -4.52%. In aggregate, investment manager performance in Large Cap Value and Core were the largest contributors to relative outperformance.
- Fixed Income markets remained mixed in August, with Core lagging behind Core Plus segments. The Fixed Income Portfolio underperformed the benchmark during the month, returning -0.32% versus -0.30%. Investment manager performance in Core Plus was the largest contributor to relative underperformance.
- As of August month-end, all underlying asset class allocations in the Portfolio are within the stated four percentage point re-balancing range as outlined by the current Statement of Investment Policy.
