WHEREAS, Section 7-141.1 of the Illinois Pension Code allows certain IMRF members to purchase additional service credit in order to induce those members to retire early; and	
<b>WHEREAS</b> , Section 7-141.1 of the Illinois Pension Code requires a member contribution for the early retirement service credit; and	
<b>WHEREAS</b> , Section 414(a) of the Internal Revenue Code provides that contributions designated as member contributions but picked-up by the employer shall be excluded from taxable income until distributed as a refund, annuity or death benefit; and	
<b>WHEREAS</b> , it is desirable that the member contributions required by the IMRF early retirement incentive be paid by the employer.
