The Committee next discussed Senate Bill 104. This bill, introduced by Senator Murphy, would, for new members only, exclude from pensionable wages payments received for unused sick and vacation time. It would also terminate a provision allowing members to convert unused, unpaid sick time to service credit. After discussion, Ms. Henry moved to recommend that the Board support the bill. Ms. Copper seconded the motion.

The Committee next discussed House Bill 239. This bill, introduced by Representative Yingling, would, if there is a hearing regarding eligibility for a pension due to felony forfeiture, require the fund to notify the Attorney General and the state's attorney of the county in which the felony occurred. It also would grant those individuals that authority to contest the eligibility and seek judicial review. After discussion, Ms. Copper moved to recommend that the Board remain neutral on the bill. Ms. Henry seconded the motion.

This bill, introduced by Representative Franks, would require that an annuity above \$2,000 be offset by the amount of salary received in that position, if an annuitant returns to the same employer in a similar position. After discussion, Ms. Copper moved to recommend that the Board oppose the bill. Mr. Stulir seconded the motion.

The Committee next discussed a proposed House Bill from Representative Harris. This bill would temporarily allow annuitants who retired prior to the passage of civil unions and/or marriage equality but then got married under those laws to repay their surviving spouse refund and regain eligibility for the benefit. For IMRF only, it would also allow surviving spouse benefits to be paid for the second spouse of annuitants who retired before March 26, 1992 and did not receive a refund of their surviving spouse contributions. After discussion, Ms. Henry moved to recommend that the Board remain neutral on the bill. Ms. Copper seconded the motion.
