The Committee next discussed House Bill 3177. This bill, introduced by Representative Yingling, would require that if an annuitant was receiving a pension and is convicted of a non-job related felony, then the pension fund would be required to suspend the pension during the period of incarceration. The annuitant could then apply for the pension to be reinstated upon his or her release. After discussion, Ms. Henry moved to recommend that the Board oppose the bill. Ms. Copper seconded the motion.

The Committee next discussed House Bill 3762. This bill, introduced by Representative Morrison, would, allow participating municipalities, by ordinance, to cease participation in IMRF and create their own plans. The employer could then set any benefits it wishes "to the extent permitted under the state or federal constitutions". Upon creation of the new fund, all employee contributions, plus interest at 6% per year, plus an equal amount to be deemed employer contributions, would be transferred from IMRF to the new fund. After discussion, Ms. Henry moved to recommend that the Board oppose the bill. Ms. Copper seconded the motion.
