MEETING NO. 2016-04-LC ILLINOIS MUNICIPAL RETIREMENT FUND LEGISLATIVE COMMITTEE MEETING MINUTES

The Committee next discussed the one proposal remaining from the Board's 2016 Legislative Agenda. This proposal would codify a current Board rule that IMRF will accept one past service purchase payment after termination, as long as a valid application is received while the member is still active. After discussion, Ms. Williams moved to recommend that the Board continue to pursue this proposal as part of the 2017 legislative agenda. Mr. Kuehne seconded the motion.

Next, the Committee discussed a staff proposal to require that Board candidates be vested in IMRF in order to qualify to run for the Board (instead of requiring that candidates have eight years of service credit) for the 2017 legislative agenda. After discussion, Ms. Thompson moved to recommend that the Board include the proposal in its legislative agenda. Ms. Williams seconded the motion.

The Committee then reviewed a second proposal from staff to clarify that the Accelerated Payment will be applicable if the increase in reported earnings is more than the greater of 6% or 1.5 times CPI to correct a drafting error that uses the term *salary* instead of *reported earnings*. After discussion, Mr. Kuehne moved to recommend that the Board include this proposal in its 2017 legislative agenda.
