Committee Member Kuehne joined the meeting at 9:08 am.

(18-08-03) Edna Roque - Total and Permanent Disability Denial

Written materials including medical records; member, employer, and physician questionnaires; written opinions by medical, psychiatric, and vocational rehab consultants; and a written statement of claim from the member were provided to the committee members for review prior to the hearing. Ms. Roque appeared via telephone before the Committee. The Committee heard testimony from the member. The Committee also heard comments from its medical and psychiatric consultants and from IMRF staff.

After deliberation, the Committee recommends that the Board uphold the staff decision denying total and permanent disability benefits to Ms. Roque. The Committee was not persuaded that the medical evidence in the record rose to the level of total and permanent disability as defined in Section 7-150 of the Illinois Pension Code where Ms. Roque's testimony was inconsistent with the medical evidence in the record. For example, Ms. Roque testified to being "home confined" by doctor order, yet there was nothing in the medical records to support Ms. Roque being medically required to stay home. The Committee found the opinions of the medical, psychiatric, and vocational rehab consultants to be more persuasive because the opinions were based on the restrictions found in the medical records.

(18-08-04) Mairicait O'Neill - Total and Permanent Disability Denial

Written materials including medical records; member, employer, and physician questionnaires; written opinions by medical, psychiatric, and vocational rehab consultants; and a written statement of claim from the member were provided to the committee members for review prior to the hearing. Ms. O'Neill appeared in person with her attorney Stephen Tousey. The Committee heard testimony from the member and heard argument from Attorney Tousey. The Committee also heard comments from its medical and psychiatric consultants and from IMRF staff.

After deliberation, the Committee recommends that the Board uphold the staff decision denying total and permanent disability benefits to Ms. O'Neill. The Committee was not persuaded that the medical evidence in the record rose to the level of total and permanent disability as defined in Section 7-150 of the Illinois Pension Code. The Committee found the opinions of the medical, psychiatric, and vocational rehab consultants to be more persuasive than Ms. O'Neill's testimony because the opinions were based on the restrictions found in the medical records. Moreover, those opinions found that, considering the restrictions found in the medical records, Ms. O'Neill was capable of performing work at a light physical demand level.
