After deliberation, the Committee recommends that the Board uphold the staff decision denying temporary disability benefits to Ms. Lind. The Committee was not persuaded by Ms. Lind's testimony regarding the basis of her not seeking additional treatment for her conditions. The Committee was persuaded by the opinions of the psychiatric consultant that Ms. Lind's level of treatment is not reflective of a disabling psychological condition. Therefore, the Committee was not persuaded that Ms. Lind met the eligibility requirement that the disabling condition prevented Ms. Lind from performing her job duties as required by Section 7-146 of the Illinois Pension Code.
