(20-05-03) Candance L. Janowiak - Denial of Temporary Disability

Written materials including medical records, member, employer, and physician questionnaires; written opinions by the psychiatric and medical consultant; and a written statement of claim from the member were provided to the committee members for review prior to the hearing. Ms. Janowiak did not appear for the hearing and requested that her appeal be determined based on the documentation in her file. IMRF staff summarized the contents of Ms. Janowiak's file for the Committee.

(20-05-04) Shannon Carnahan - Denial of Temporary Disability

Written materials including medical records, member, employer, and physician questionnaires; written opinions by the psychiatric consultant; and a written statement of claim from the member were provided to the committee members for review prior to the hearing. Mr. Carnahan did not appear for the hearing and requested that his appeal be determined based on the documentation in his file. IMRF staff summarized the contents of Mr. Carnahan's file for the Committee.

At 1:15 pm Trustee Wallace made a motion to go into closed session to discuss evidence presented in open session in the Janowiak and Carnahan temporary disability appeals pursuant to Section 2(c)(4) of the Open Meetings Act. Trustee Kuehne seconded the motion which was approved by a unanimous 6-0 roll call vote.

At 1:21 pm Trustee Kuehne made a motion to return to open session. Trustee Wallace seconded the motion which was approved by a unanimous 6-0 roll call vote.

After deliberation, the Committee recommends that the Board affirm the staff decision denying temporary disability benefits to Ms. Janowiak. The Committee was not persuaded that the medical records supported Ms. Janowiak's subjective complaints. Therefore, the Committee was persuaded by the medical and psychiatric consultants' opinions that the evidence did not show that a disabling condition prevented Ms. Janowiak from performing her job duties as required by Section 7-146 of the Illinois Pension Code for the disability time period.
