(20-08-04) Maricarmen Moy- Denial of Total and Permanent Disability

Written materials including medical records, member, employer, and physician questionnaires; written opinions by the medical consultant and the independent medical examiner; and a written statement of claim from the member were provided to the committee members for review prior to the hearing. Ms. Moy submitted memoranda as late submissions to the Committee. Additionally, IMRF staff submitted a corrected IME report as a late submission to the Committee. Ms. Moy appeared for the hearing via videoconference and was represented by her attorney Mr. Steven Jesser. The Committee heard testimony from Ms. Moy and argument from her attorney.

(20-08-05) Aurthela Jackson - Denial of Total and Permanent Disability

Written materials including medical records, member, employer, and physician questionnaires; written opinions by the medical consultant; and a written statement of claim from the member were provided to the committee members for review prior to the hearing. Ms. Jackson appeared for the hearing via telephone and provided testimony to the Committee.

At 2:23 pm Trustee Kuehne made a motion to go into closed session to discuss evidence presented in open session in the Moy and Jackson total and permanent disability appeals pursuant to Section 2(c)(4) of the Open Meetings Act. Trustee Stafford seconded the motion which was approved by a unanimous 6-0 roll call vote.

At 2:42 pm Trustee Stafford made a motion to return to open session. Trustee Wallace seconded the motion which was approved by a unanimous 6-0 roll call vote.

(20-08-04)(cont.) Maricarmen Moy- Denial of Total and Permanent Disability

After deliberation, the Committee recommends that the Board consider all late submissions and affirm the staff decision denying total and permanent disability benefits to Ms. Moy. The Committee did not find Ms. Moy's testimony to be credible where she was able to craft multiple rebuttal memoranda, even with assistance, and was able to recall and articulate job duties and specific clients from more than five years ago. Moreover, the Committee was not persuaded that Ms. Moy's vertigo and dizziness were disabling conditions where her physician continues to clear her for driving and she in fact continues to drive. Therefore, the Committee was persuaded by the medical consultants' opinions that the objective medical evidence did not show that a disabling condition prevents Ms. Moy from engaging in gainful activity as required by Section 7-150.

(20-08-05)(cont.) Aurthela Jackson - Denial of Total and Permanent Disability

After deliberation, the Committee recommends that the Board affirm the staff decision denying total and permanent disability benefits to Ms. Jackson. The Committee affirmed staff's denial on two independent basis, each of which are sufficient for denial on their own. The Committee was not persuaded that the medical records supported Ms. Jackson's subjective complaints of weakness and fatigue. The Committee was persuaded by the medical consultant's opinion that the objective medical evidence did not show that a disabling condition prevents Ms. Jackson from engaging in gainful activity as required by Section 7-150(a)(1). Secondly, the Committee found that Ms. Jackson has failed to submit to a reasonable physical examination in violation of Section 7-150(b)(4) where she has cancelled or refused to attend a functional capacity evaluation on three occasions.
