(20-11-06) Litigation Report

Attorney Shuliga presented an update regarding pending or recently concluded litigation. No final action was taken.

(20-11-07) Linda Howard – Denial of Total and Permanent Disability

Written materials including medical records, member, employer, and physician questionnaires; written opinions by the medical consultant; and a written statement of claim from the member were provided to the committee members for review prior to the hearing. Ms. Howard appeared for the hearing via videoconference and was accompanied by her husband, Bill Howard. The Committee heard testimony from Linda and Bill Howard during the hearing.

(20-11-08) Kelly Lange - Denial of Total and Permanent Disability

Written materials including medical records, member, employer, and physician questionnaires; written opinions by the medical consultant; and a written statement of claim from the member were provided to the committee members for review prior to the hearing. Prior to the hearing date, Ms. Lange notified IMRF staff that she would not be participating in the hearing, so her appeal was decided based upon the documentation in the file.

At 2:21 pm Trustee Stanish made a motion to go into closed session to discuss evidence presented in open session in the Howard and Lange total and permanent disability appeals pursuant to Section 2(c)(4) of the Open Meetings Act. Trustee Stafford seconded the motion which was approved by a unanimous 6-0 roll call vote.

At 2:34 pm Trustee Wallace made a motion to return to open session. Trustee Stanish seconded the motion which was approved by a unanimous 6-0 roll call vote.

(20-11-07)(cont.) Linda Howard - Denial of Total and Permanent Disability

After deliberation, the Committee recommends that the Board affirm the staff decision denying total and permanent disability benefits to Ms. Howard. The Committee finds that the medical records and Ms. Howard's testimony show that the medical condition of inflammatory arthritis existed prior to Ms. Howard's earliest date of IMRF participation. Therefore, Ms. Howard's disability resulted

from a condition which pre-existed her participation in IMRF. Therefore, the Committee finds that Ms. Howard is not meet the eligibility requirements for total and permanent disability benefits as set forth in Section 7-150(b)(5).

(20-11-08)(cont.) Kelly Lange - Denial of Total and Permanent Disability

After deliberation, the Committee recommends that the Board affirm the staff decision denying total and permanent disability benefits to Ms. Lange. The Committee affirmed staff's denial on two independent bases, each of which are sufficient for denial on their own. The Committee was not persuaded that the medical records supported Ms. Lange's claim where her own hematologist opined that her medical condition did not prevent her form working. The Committee was persuaded by the medical consultant's opinion that the objective medical evidence did not show that a disabling medical condition prevents Ms. Lange from engaging in gainful activity as required by Section 7-150(a)(1). Secondly, the Committee found that Ms. Lange has failed to submit to a reasonable physical examination in violation of Section 7-150(b)(4) where she has cancelled or refused to attend a functional capacity evaluation on four occasions.
