# (24-11-04) (Presentation of the 2024 Third Party Penetration Testing and Vulnerability Assessment Performed (David Anderson, CLA))

The 2024 Third Party Penetration Testing and Vulnerability Assessment results presented by David Anderson, CLA. The Penetration Testing and Vulnerability Assessment performed related to the Information System Area: External Penetration Assessment (EPA), Remote Social Engineering (RSA), Web Application Penetration Test (WAPT), Internal Penetration Assessment (IPA), and Wireless Network Security Assessment (WNSA).

The 2024 Penetration Testing and Vulnerability Assessment performed related to the Information System Area resulted in the following:

• (A) External Penetration Assessment: No critical or high-risk vulnerabilities. CLA was unable to gain unauthorized access to IMRF systems or sensitive data from the outside (from the internet).

- (B) Remote Social Engineering Email Phishing: No vulnerabilities noted.
   None of the targeted users visited the malicious website or followed our instructions.
- (C) Web Application Penetration Test Member / Employer Portals: CLA
  was able to find high risk vulnerabilities. 1) Cross-site scripting flaw could
  allow attackers to compromise application users 2) Applications disclosed
  participants' full social security numbers.
- (D) Internal Penetration Assessment: CLA was able to find high risk vulnerabilities on the internal systems that allowed CLA to gain administrative rights to the network.
- (E) Wireless Network Security Assessment: CLA identified no critical or high-risk vulnerabilities in the wireless network.

Quizzes were administered after completion of the training. The average scores were over 90%.
