LEGISLATIVE COMMITTEE MEETING
MINUTES**

The Committee began by reviewing the minutes of the December 19, 2024, meeting of the Legislative Committee.

The Committee then reviewed the details of the possible Board Trustee Springfield Drive-Down.

The Committee was then presented with House Bill 1736, sponsored by Representative Avelar. In the provision applicable to IMRF, adds the Joliet Port District on the list of qualified instrumentalities that allows them to participate in IMRF upon approval by the Board.

Trustee Kosiba moved to adopt the staff recommendation to remain neutral on the bill and Trustee Copper seconded the motion.

The Committee was then presented with House Bill 2358, sponsored by Representative Weber. In the provision applicable to IMRF, requires all benefit payments to begin within 30 days of receipt of a full and complete application filed with the Fund.

Trustee Miller moved to adopt the staff recommendation to remain neutral on the bill and Trustee Copper seconded the motion.

The Committee was then presented with House Bill 2848, sponsored by Representative Kifowit. In the provisions applicable to IMRF, reinstates a provision allowing police chiefs in communities with an Article 3 (downstate police) pension.

After discussion, Trustee Kosiba moved to oppose the bill and Trustee Kuehne seconded the motion.

The Committee was then presented with House Bill 3113, sponsored by Representative Wilhour. Requires funds to calculate a "hypothetical Social Security benefit" for all Tier 2 members who do not also participate in Social Security and to increase their benefits to that amount plus \$1 if that amount is greater than the benefit for that service credit in the fund.

After discussion, Trustee Miller moved to oppose the bill and Trustee Isaac seconded the motion.
