## Monthly Performance Summary

As of June 30, 2022

## IMRF Performance Summary

- The Illinois Municipal Retirement Fund (“IMRF”) ended June 2022 with a market value of \$48.4 billion, down for the month by approximately \$2.77 billion. IMRF returned -5.15% during the month, underperforming the Total Fund Benchmark, which returned -4.73%. Global financial markets were challenged in June sending stock prices into bear-market territory. Inflation reached a 40 year high for the year, causing the Federal Reserve to raise interest rates by 75 bps, its largest increase since 1994.
- U.S. Equity markets fell during the month, with S&P 500 losses hitting 20% for the year, marking the worst six months of a year since 1970. Growth stocks continued to underperform value in both the small and large cap spaces. The U.S. Equity Portfolio underperformed the benchmark during the month, returning -8.58% versus -8.21%. In aggregate, investment manager performance in Large Cap Growth was the largest contributor to relative underperformance.
- International Equity markets were down in June as high inflation has become an issue affecting global economies around the world. After lifting most of its COVID restrictions, China began to see some economic improvement in June. The International Equity Portfolio underperformed the benchmark during June, returning -8.78% versus -8.60%. Investment manager performance in Large Cap Growth and Large Cap Core were the largest contributors to relative underperformance.
- U.S. Treasury yields rose across the board in June, most noticeably those on the short end leading to a flatter curve. The Fed is signaling another 175 bps in increases by the end of the year. The Fixed Income Portfolio underperformed the benchmark during the month, returning -2.24% versus -2.10%. Investment manager performance in core plus and bank loans were sources of underperformance.
- As of June month-end, all underlying asset class allocations in the Portfolio are within the stated four percentage point rebalancing range as outlined by the current Statement of Investment Policy.
