IMRF Performance Summary

- The Illinois Municipal Retirement Fund (“IMRF”) ended June 2024 with a market value of \$54.04 billion, up for the month by approximately \$479 million. IMRF returned 0.73% during the month, underperforming the Total Fund Benchmark, which returned 1.42%. Returns in June slowed from the strong results in May, but both growth and defensive assets achieved positive returns for the month while real assets and commodities posted losses.
- The broad U.S. Equity market was positive for the month, while Large Cap stocks outperformed Small Cap. The U.S. Equity Portfolio underperformed its benchmark during June, returning 1.88% versus 2.69%. The portfolio's allocation to Small Cap was the largest contributor to relative underperformance.
- Non-US equity markets were mixed in June, with Developed Markets returning -1.61% while Emerging Markets were positive, returning 3.94% for the month. The International Equity portfolio underperformed the benchmark during the month, returning -0.42% versus -0.10%. In aggregate, investment manager performance in International Large Cap Value and Emerging Markets were the largest contributors to relative underperformance.
- In the midst of ongoing interest rate uncertainty, the Fixed Income Portfolio slightly outperformed the benchmark during the month, returning 0.89% versus 0.88%. Active Fixed Core and Bank Loans managers were the largest contributors to relative outperformance.
- As of June month-end, all underlying asset class allocations in the Portfolio are within the stated four percentage point re-balancing range as outlined by the current Statement of Investment Policy.
