
- Investments are managed prudently

Target Asset Allocation





Annual Total Fund Returns 1982-2014



- In 1982, began operating under the "Prudent Person Rule"
- 7.5% assumed return
- · Annualized Total Fund return 1982-2014: 10.24%

- 6 periods in which IMRF lost money
- 4 periods < 7.5%
- 23 periods > 7.5%
- 20 periods double-digit returns





2015 Minority Manager Allocations

- Fixed Income \$450 million in allocations
 - \$100 million direct mandate to Garcia Hamilton (Latino)
 - \$150 million added to Garcia Hamilton (Latino)
 - \$200 million added to Progress Fixed Income manager of managers program (African American)
- Real Estate \$100 million commitment
 - \$25 million direct mandate to Oak Street Real Estate Capital Fund III (Latino, Illinois based)
 - \$75 million mandate to Artemis Real Estate Minority Manager of Manager Program (Female)




History of African American Owned Investment Managers December 31, 2004 through October 31, 2015



History of Latino American Owned Investment Managers December 31, 2004 through October 31, 2015




Assets Under Management (in millions)
