**2016 Executive
Trustee Election**

In November, IMRF employers will elect one Executive Trustee for a five-year term. The five-year term of office will run from January 1, 2017, through December 31, 2021. This *Special Edition Employer Reminder* includes election details for eligible voting members of IMRF.

Eligible candidates

A nominee for Executive Trustee must be employed by an IMRF employer as a chief executive officer, chief finance officer, or other officer, executive, or department head. The nominee must also participate in IMRF and have at least eight years of IMRF service credit as of December 31, 2016.

The following IMRF members submitted nominating petitions with signatures from at least three IMRF employers for the 2016 Executive Trustee election:

Eligible voters

Not all Authorized Agents can vote in the Executive Trustee election. Only those Authorized Agents who are members of IMRF and whose Notice of Appointment of Authorized Agent ([IMRF Form 2.20](#)) filed with IMRF indicates they have been given such power may vote. Otherwise, the unit's governing body would cast the ballot, and the clerk or other proper official would certify the ballot.

Distribution of ballots

Ballots, along with candidates' biographies, were mailed to Authorized Agents or governing bodies (as appropriate) on October 12, 2016. [Candidates' biographies are also available for review on IMRF's website.](#)

Completed ballots must be returned to IMRF's Oak Brook or Springfield office by 4:30 PM, December 8, 2016. Election results will be certified at the Board of Trustees meeting on December 16, 2016.

Additional fall elections

There will be no Employee Trustee election as current Employee Trustee **Alex Wallace, Jr.**, of the Oswego Community Unit School District 308, is unopposed.
