2017 Executive Trustee Election

This fall, IMRF employers will elect one Executive Trustee for a five-year term. The five-year term of office will run from January 1, 2018, through December 31, 2022. This *Special Edition Employer Reminder* includes election details for eligible voting members of IMRF.

Eligible candidates

A nominee for Executive Trustee must be employed by an IMRF employer as a chief executive officer, chief finance officer, or other officer, executive, or department head. The nominee must also participate in IMRF and be vested as of December 31, 2017.

Eligible voters

Not all Authorized Agents can vote in the Executive Trustee election. Only those Authorized Agents who are members of IMRF and whose Notice of Appointment of Authorized Agent ([IMRF Form 2.20, available for download at \[www.imrf.org\]\(http://www.imrf.org\)](#)) filed with IMRF indicates they have been given such power may vote; the ballot confirms voting eligibility. Otherwise, the unit's governing body would cast the ballot, and the clerk or other proper official would certify the ballot.

Distribution of ballots

Ballots, along with candidates' biographies, were mailed to Authorized Agents or governing bodies (as appropriate) on October 11, 2017. [Candidates' biographies are also available for review on IMRF's website.](#)

Completed ballots must be received by IMRF's Springfield or Oak Brook office by 4:30 PM CST, Tuesday, December 12, 2017.
